The last payment of the deposit is possible at the latest during the administrative acceptance.

- d) Entry fees may be refunded only:
- to candidates who are not accepted,
 - in the case the Competition will not take place,
 - if the Competitor withdraws his entry no later than the Monday before the Competition. If the withdrawal is announced to the organizer between that Monday and the opening of the administrative checking, only 50% of the entry fee will be refunded.

IV. INSURANCE

a) Insurance coverage of the organizer

The ACCR concluded with „Allianz Insurance, a.s. through the company PLATINUM Consulting s. r.o., the frame insurance contract No. 400046134 on insurance of liability of the organizer for damage caused to the others in connection with a sport event up to the sum of CZK 10.000.000.

b) Insurance of competitors and crews

A part of the frame insurance contract No. 400046134 is insurance of cars of the participants against damages caused to third persons up to the sum of CZK 10.000.000 per one insurance event with co-participation of CZK 5.000. Any damage below CZK 5.000 will be paid by the driver who caused the damage: damages above CZK 5.000 will be paid by the insurance company without any co-participation of the insured. However, the insurance does not cover liability for the damages caused by event participant that the competitors cause each other in the course of the sport event.

c) Each driver is obliged to conclude his personal injury insurance and to present a proof on request of the administrative checking. The insurance of foreign drivers must include coverage of costs for possible medical treatment in the CR.

V. NOISE CHECKING

For all cars, a limit of 100 dB is imposed.

VI. PRIZES AND CUPS

The podium ceremony on the circuit will be held immediately after the races. The winners of the 1st, 2nd and 3rd prizes will follow instructions of the marshals. Failure to attend this ceremony will be penalized by the loss of any monetary award / benefit associated with the corresponding position at the end of the race.

VII. OTHER INFORMATION

a) Protests - Appeals

All protests will be lodged in accordance with the Code.

All protests must be made in writing and handed to the Clerk of the Course or his assistant, or in their absence to any of the Stewards of the meeting, together with the sum of € 460. If the protest requires the dismantling and re-assembly of different parts of a car, the claimant must make a deposit of € 10.000 maximum.

Competitors have the right to appeal, as laid down in Articles 15.2, 15.3 and 15.4 of the Code and also as set out in the Rules of the International Court of Appeal. The fee for the appeal is € 900.

b) The Drivers' Liaison

The Drivers' Liaison Officer will be recognizable by an orange vest. His picture will be posted on the Official Notice Board. He may be reached at the drivers' paddock.
